

PURPOSE

The purpose of this file is to assist trial secretaries in completing all required documentation and calculations and to aid in the organization on your event. This will reduce (but not completely eliminate) the possibility of data entry and math errors. Our long-term goal is to get as close to paperless with all our trial information as possible. Using this file will allow you to email the completed document to the PSA Secretary after your trial is complete and cut down on the amount of paperwork you will need to complete.

This is designed for you to begin using as soon as you open up registration for your event. If you open it and add competitors as they register it will keep track of how many registrations you have for each day and AUTOMATICALLY CALCULATE the order of your competitors on trial day.

WHAT DO YOU NEED TO USE THIS?

A laptop or desktop computer and Microsoft Excel. This is a Microsoft Excel Macro Enabled file. When you open the file, you will be prompted with a security alert to enable macros. You must enable macros on this document when you open it for this to function as intended, you may also have to “Trust Document” if prompted. This has not been tested on older versions of excel beyond Excel 2007. This has been tested on Excel for Mac and Windows.

Because this is way beyond a simple spread sheet and has programming built in this will not run from the cloud, nor will it function on any other spreadsheet program like Google Sheets, or Numbers.

Having an internet connection on the trial field is not necessary. However, if you do have an internet connection on the computer where you are using this document there are links to open directly up to the PSA website in order to check memberships and access the official rulebook.

STRUCTURE OF DOCUMENT

The Excel file has 4 tabs along the bottom that you will use to access different information as you progress through your event. All tabs are locked and only the fields that are intended to contain information entered by a trial secretary can be edited. The tabs are:

Dashboard – you will set trial information on this tab such as dates of event, trial location, judge, decoys, and how many memberships and scorebooks you sold at your event. This also has an overview of the number of competitors each day and how many passed and monies owed to PSA.

Trial Database – this is used as the trial log and contain all competitor and score information.

Weekend Awards – at conclusion of event you will select teams who received awards.

PSA Money Sheet – Breaks down and totals trial entries, memberships and scorebooks sold to provide a total the club will owe to PSA for the event.

WHAT DOES IT DO?

This file is designed to handle a two-day trial with a maximum of 50 entries (25 each day). The file will calculate competitor order for obedience and protection, calculate total scores, percentage of overall score, and show a breakdown of scores for each level so that you are able to determine who will receive medals, trophies, and plaques. It will calculate the amount of monies owed to PSA at the end of your event. Once completed the file can then be emailed to the member of the PSA Secretary team assigned to your region or event and will be your official record of trial logs/results, money sheet, and awards sheets.

By requiring the use of this document for trials we are now able to post all trial results online in a searchable format.

IMPORTANT THINGS TO KNOW/REMEMBER

- This will work on Apple computers or Windows machines if they have Microsoft Excel installed.
- You must enable macros when opening file.
- All entries made into the workbook should be made in ALL CAPS. You will receive an error if you attempt to enter information into the workbook that is not in ALL CAPS.
- Please get the most recent version of this document from PSA Secretary prior to your event. There are formulas included in the file that will have to be changed in the event there are any future changes made to the scoring or level structure. If an incorrect file is used it will be returned to the hosting club to transfer all their trial results to the proper file before their trial results can become official.
- Score sheets will still have to be mailed in at the completion of your event. The PSA Secretary assigned to your region or event will audit the file and make sure all the entries are correct before the results get posted.
- **I recommend saving your file after every competitor's score you enter as a safety measure in the event your computer crashes or any various other digital issues strike.**
- In the event, you are having a two day event that is actually separate such as a Regional and a Club Trial OR a Mock Trial and a Trial you should probably use two separate copies of the file. One for your Regional and one for your club trial. Since this file combines and analyses scores over two days it will be simpler to just treat them as separate events and do two files, one for each event.

Dashboard Trial Database Weekend Awards PSA Money Sheet

The first thing to do when receiving this file should be to enter the relevant trial information.

The trial dates must be entered before continuing to the rest of the tabs for everything to function properly.

In the event, you only have a one day event please go ahead and enter two consecutive dates in the date section. You will only enter information on the log sheet for the proper date.

You may enter the rest of the data at any time prior to locking the document for submission to the PSA Secretary. In fact, you will not enter the total number of memberships and scorebooks sold until the last day of your event.

The "STATUS" of the workbook is displayed on the bottom right of this page along with the buttons for the judge to lock or unlock the workbook.

You can adjust the viewing size of this page to make it fit within your display window by using the excel view adjustment in the lower right hand corner or your excel window.

TRIAL DATABASE



The screenshot above is the default view of the document in the Trial Database Tab. It shows 50 entries with the top 25 positions for Day 1 and the bottom 25 positions for Day 2. The column “Registration Order” is numbered Day 1-01, Day 1-02, Day1-03, etc for each day. As you receive entries you will fill in the competitor positions in the order you receive your entries for each day. No need to worry about sorting them by level at this point. The document will do it for you when it is needed. Just add entries as you receive them.

As you add entries you will enter the following fields:

- ✓ LEVEL ENTERED *once you enter a value in this field on the form the “STATUS” column will set to the status of “ACTIVE”
- ✓ THE LEG OF TITLE BEING ATTEMPTED
- ✓ THE MEMBER # IF KNOWN OF THE HANDLER
- ✓ THE HANDLERS FIST AND LAST NAME
- ✓ THE DOGS NAME
- ✓ WHETHER THE DOG IS “OWNER TRAINED”
- ✓ THE BREED OF THE DOG *if for some reason a suitable breed or cross isn’t listed chose “Other” and send an email to webmaster@psak9-as.org requesting the breed be added to the list.
- ✓ THE OWNER OF THE DOGS FIRST AND LAST NAME

Once you have completed the entry, save the file.

The status column has 8 options; “ACTIVE”, “PASS”, “NO PASS”, “NO PASS (BITE)” meaning the dog bit during a portion they were not supposed to, “NO PASS (NO OUT)” meaning the dog failed to out after the allowed commands, “PULL”, “NO SHOW”, or “DQ” meaning the team was disqualified for some reason. You will change this status to the appropriate status as your

trial progresses. “ACTIVE” status should mean that the competitor is still active in the trial and still has a level to show in, the only time you will change this to “PASS” is after the competitor passes both obedience and protection. A “PASS” status means the competitor has achieved their certificate, title or leg.

At any time when the competitor pulls, receives a no pass or a DQ you may change the status at that time showing the disposition of the entry at the trial.

The screenshot above represents an example of what your sheet should look like. The active row is highlighted yellow. You may change the active row by selecting any cell within the table that you want to edit or add data to.

All entries were added in order received and status has been changed to “ACTIVE”.

The morning of your trial once all entries are completed and you are ready to get your competitor order you will click the “DAY 1 – OBEDIENCE” BUTTON. This will automatically sort from top to bottom your competitor order Level PDC-SD, PDC, PSA1, PSA2, and finally PSA3. Competitor order as set by the official PSA Rulebook is (last to register first to go in obedience). *Judges may alter this order for example to accommodate a handler who is showing multiple dogs or perhaps a female in heat the judge elects to move to the end of the rotation. (see reference section later in the manual to learn how to move entries around).

DAY (1 or 2) – OBEDIENCE – ORDER OF COMPETITORS

The following screenshot shows how the data is manipulated after you press the “DAY 1 – OBEDIENCE” BUTTON. To return to the preview view showing all entries by registration order press the “DEFAULT VIEW” button. This view is only showing the DAY 1 entries, all other entries or rows of data without a level selected are hidden. *note the sort is beginning with PDC-SD and going down to PSA3. The competitor order is calculated by the Registration Order number from highest (or last) to lowest (or first).

ADDING OBEDIENCE SCORES

After each competitor you will enter the score they received. This score will be on the score sheet completed by the judge. Once you double check all the math calculation on the sheet add the obedience score in the OB column. If a team does not pass, is disqualified, or pulls from the trial change their “STATUS”. A passing obedience score means the teams “STATUS” remains “ACTIVE”. If a team does not pass obedience or is DQ’d enter a zero for their protection score.

Your sheet should resemble the following image at this point in the trial.

The following screenshot shows how the data is manipulated after you press the “DAY 1 – PROTECTION” BUTTON. This view is only showing the DAY 1 entries, all other entries or rows of data without a level selected are hidden. *note the sort is beginning with PDC-SD and going down to PSA3. The competitor order is now calculated by the obedience score. Lowest scores first, highest scores last. If you have entered the obedience scores properly you will see the zeros in the column for protection for those teams that did not pass obedience or were DQ’d.

Once you have the competitor order you will organize the score sheets, notify the judge and competitors of their order of competition and begin entering protection scores as you receive them.

ADDING PROTECTION SCORES

After each competitor you will enter the score they received. * I recommend saving the file after each score entered. This score will be on the score sheet completed by the judge. Once you double check all the math calculation on the sheet add the protection score in the PR column. If a team does not pass, is disqualified, or pulls from the trial change their "STATUS". A passing protection score means the teams "STATUS" will now change to a "PASS". In the "HONORS" column you should enter N/A for all PDC levels, NA for any level who did not pass, No for a passing score in both obedience and protection that is not with distinction, or with highest distinction, (the judges will help you determine this). For more info on the Honors criteria please reference the PSA Rulebook.

At the end of your trial day you should not have any competitors still set to "ACTIVE." Once all the results have been entered we are now ready to analyze the trial to see who has the 1,2,3rd place for the day on levels, PSA1, PSA2, & PSA3

ANALYZING RESULTS

There are buttons along the top for each level for each day in order to figure the rankings. When you press the button some additional columns open up. You will now be able to see the amount of points possible for each level in each phase along with a percentage of points earned calculation for each phase and for overall points earned. To toggle between levels to check scores simply press the appropriate button from the top menu. When finished analyzing the results along with the judge you may press the “DEFAULT VIEW” button on the left and prepare for your day two. You will now repeat the steps to manage your second day of the event choosing the appropriate buttons for DAY 2 – OBEDIENCE, DAY 2 – PROTECTION, etc.

ANALYZE OVERALL RESULTS

*If a team showed on each day their name may appear twice in your list. It does not matter which selection you make if you select the proper team (handler and dog) name for the award spot. The dates, judge, secretary, and location are populated on this page from your “Dashboard” tab.
